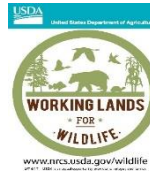


FLORIDA NATURAL AREAS INVENTORY / USDA NRCS
SOUTHEAST LONGLEAF PINE ECOSYSTEM OCCURRENCES
GEODATABASE AND WEB MAP
DATA LICENSE AGREEMENT



This data license agreement applies to the Southeast Longleaf Ecosystem Occurrences Geodatabase (LEO_GDB) and password protected web map ("Web Map") produced by the Florida Natural Areas Inventory (FNAI) in cooperation with USDA's Natural Resources Conservation Service (NRCS).

LEO_GDB and Web Map version/date: LEO_GDB v1, July 2020

FNAI IS WILLING TO LICENSE THE ABOVE DATA AND WEB MAP TO YOU ONLY UPON CONDITION THAT YOU ACCEPT ALL OF THE TERMS AND CONDITIONS CONTAINED IN THIS DATA LICENSE AGREEMENT.

This license agreement (Agreement) is between the end user (Licensee) and the Florida Natural Areas Inventory (FNAI) in cooperation with the NRCS, and gives Licensee certain limited rights to use the LEO_GDB electronic data, documentation ("Data") and Web Map. All rights not specifically granted in this Agreement are reserved to FNAI/NRCS.

Reservation of Ownership and Grant of License: the Data and Web Map provided by FNAI represents intellectual property. FNAI/NRCS retain exclusive rights, title, and ownership of the copy of the Data and Web Map licensed under this Agreement and, hereby, grant to Licensee a personal, nonexclusive, nontransferable license to use the Data and Web Map on the terms and conditions of this agreement. From the date of receipt, Licensee agrees to use reasonable effort to protect the Data and Web Map from unauthorized use, reproduction, distribution, publication, or sale.

Permitted Uses:

1. Licensee may use this copy of the Data and Web Map on a computer network serving an unlimited number of computer terminals associated with the authorized Site. A Site is defined as a single building or complex of buildings with a unique street address. The computer network includes computers, laptops, or other devices that may be used remotely but are associated with the authorized Site. Licensee may not share, transfer, loan, rent, lease, or sell this copy of the Data to another user outside the authorized Site. Licensee may not share access information, including Web Map links, passwords or other log-in information associated with authorized access to the Web Map with another user outside the authorized Site.
2. The Data are produced for the purposes of longleaf ecosystem conservation planning and assessment, ecological restoration, research, and education for the benefit of United States taxpayers. Licensee agrees to not use the Data and Web Map for any other purpose.
3. Licensee may produce maps, tables, and/or reports, using all or portions of the Data and Web Map provided. All or portions of the Data and Web Map may be merged directly into reports produced by the Licensee. The "Southeast Longleaf Pine Ecosystem Occurrences Geodatabase," Version number and date must be cited as the source of the Data and Web Map in all products, publications, or presentations containing all or portions of the Data.
4. Licensee may use all or portions of this Data, alone or together with other data, to perform original analysis. Any products, publications, or presentations based on such analysis must cite FNAI/NRCS as a source for original data used in the analysis.

Uses Not Permitted:

1. Licensee shall not sublicense, sell, rent, lease, loan, transfer, assign, or provide access to electronic versions of the Data and Web Map, in whole or in part, to unlicensed third parties, including partner

agencies, clients or contractors. Printed maps of all or portions of these Data may only be provided to partner agencies, clients or contractors as part of a larger analysis or project related to the purposes listed under item 2 of Permitted Uses above.

2. Licensee shall not use all or portions of the Data or Web Map, in electronic, print, or other medium, to create products for distribution and sale that rely principally upon these Data. Additionally, Data shall not be used or provided in a web application or map service unless special written permission is granted by FNAI and NRCS.
3. Licensee shall not alter any substantive feature or characteristic of these Data. Alterations for aesthetic purposes, such as changes to the style and/or color of markers, polygon shadings, or fonts, are permitted.

Other conditions:

1. The Data require some understanding of data collection methods and definitions for proper use and analysis. Licensee agrees to read the Data-associated reports, documentation of methods, attribute definitions, and metadata. FNAI staff are available to advise all LEO_GDB data users regarding the technical aspects of these data.
2. Upon request, Licensee will provide FNAI and NRCS National Headquarters, Landscape Conservation Initiatives Team with a list of any reports or printed materials prepared using LEO_GDB data, and will provide a sample copy of such material, provided such materials may not be disclosed to any third party without the express written permission of the Licensee. FNAI/NRCS acknowledge that any reports or printed materials prepared by the Licensee using LEO_GDB data are the sole and exclusive property of the Licensee.
3. Licensee shall take reasonable precautions to ensure the security of LEO_GDB data.
4. Licensee will indemnify and hold FNAI/NRCS and its officers and employees harmless against any claims by third parties arising out of the use by Licensee of the Data and Web Map provided hereunder.

Term: The license granted by this Agreement shall commence upon Licensee's receipt of the Data and Web Map and shall continue for a period of one (1) year from the date of commencement of the license. FNAI shall consider the date of commencement of the license to be the date the Data and Web Map was sent to the Licensee by FNAI. At the end of one year the license shall expire, and the Licensee may not use the Data and Web Map for any new projects, maps, presentations, or analyses. This license may be renewed by authorization of a new license agreement. An updated version of the Data and Web Map will be provided with each renewal. FNAI reserves the right to terminate this Agreement at any time for Licensee's material breach of this Agreement.

Licensee understands and acknowledges that their use of these data is time-limited. This license expires on _____. Upon that date, the licensee agrees to: a) certify that all copies of these data have been destroyed or returned to FNAI; or b) complete arrangements with FNAI to update the license agreement.

Limited Warranty: The accuracy and completeness of the Data, and the opinions based thereon, are not guaranteed. Every effort has been made to provide accurate data in this package. The Licensee acknowledges that the Data and Web Map may contain some nonconformities, defects, errors, and/or omissions. FNAI/NRCS do not warrant that the Data and Web Map will meet Licensee's needs or expectations, or that all nonconformities can or will be corrected.

Liability: Although FNAI maintains high standards of data quality control, FNAI makes no warranty as to the fitness of the LEO_GDB data for any purpose, nor that the Data and Web Map are necessarily accurate or complete. **Neither** FNAI nor NRCS shall be held liable for the accuracy and completeness of these Data, or opinions or conclusions drawn from these Data. FNAI is not inviting reliance on these Data. The Data and Web Map are not always based on comprehensive or site specific field surveys. Therefore, these Data should not be

regarded as a final statement on the biological resources of the location provided, nor should these Data be substituted for on-site surveys. FNAI encourages the Licensee, at Licensee's convenience, to communicate to FNAI any errors or omissions found in these Data. Such comments serve to improve the quality of the LEO_GDB data.

FNAI/NRCS represents, to the best of its information and belief, that: a) the provision of data does not infringe any statutory or common law copyright or any proprietary right of any third party; b) the provision of data does not invade the right of privacy of any third person, or contain any matter libelous or otherwise in contravention of the rights of any third person; and c) the provision of data does not otherwise violate any federal or state statute or regulation.

Licensee will indemnify and hold FNAI/NRCS and its officers and employees harmless against any claims by third parties arising out of the use by Licensee of the Data and Web Map provided hereunder.

Waivers: No failure or delay by FNAI, NRCS or the U.S. Department of Justice in enforcing any right under this Agreement shall be construed as a waiver of any future or other exercise of such right by FNAI, NRCS or the Department of Justice.

Remedies: Failure of FNAI or NRCS to discover or object to any inappropriate use shall not constitute its consent thereto or waiver its rights. In the event Licensee's use of the Data and Web Map violates the terms of this License Agreement, FNAI may forbid and enjoin Licensee's further use of the Data.

Entire Agreement: The parties agree that this constitutes the sole and entire agreement of the parties as to the matter set forth herein and supersedes any previous agreements, understanding, and arrangements between the parties relating hereto and is effective, valid, and binding upon the parties.

Cautionary notes regarding the use of LEO Data and Web Map:

Despite the volume and detail of information in the LEO_GDB and Web Map, some important limitations apply.

- 1) LEO_GDB and Web Map data require some understanding of LEO_GDB data collection methods and definitions for proper use and analysis. Please read the LEO_GDB report which includes documentation of methods and attribute definitions. FNAI staff are available to advise LEO_GDB and Web Map users regarding the technical aspects of these data.
- 2) The LEO_GDB and Web Map are not complete for all occurrences of longleaf pine. The geographic area that encompasses the range of longleaf pine is large, highly diverse, and constantly changing. Much of this geographic area is not well-surveyed, so undoubtedly there are Longleaf Ecosystem occurrences in addition to those documented within the LEO_GDB and Web Map.
- 3) A longleaf ecosystem occurrence documented by the LEO_GDB or in the Web Map on public land does not assure its protection.
- 4) Not all LEO_GDB and Web Map longleaf ecosystem occurrences are equivalent; the size in acreage and ecological conditions of documented longleaf occurrences in the LEO_GDB ranges widely. When available, data that may reflect ecological condition using vegetation attributes, are provided in the LEO_GDB.
- 5) When available, and for the convenience of the Licensee, vegetative data for individual occurrence attributes are cross-walked by FNAI to America's Longleaf Restoration Initiative Management Categories using attribute value thresholds established by FNAI using methods documented in Data documentation. This allows the Licensee to display and analyze the Data and Web Map using the ALRI management categories, as interpreted by FNAI. The Licensee may choose to customize cross-walk thresholds in the LEO_GDB for their own analyses, using the LEO_to_Mgmt_Category_Lookup table provided in the LEO_GDB.

Despite these limitations, the LEO_GDB is important because it gives us the best picture available of where and to what extent longleaf ecosystems and stands occur, which is useful for conservation planning and assessment.
